**\*Freight and Shipping Minimums**  
Shipping minimum is \$75 invoice value.

Unless otherwise noted under “discounts” all titles ship free freight on outgoing orders if the shipping minimums are met.

#### **Carrier and standard routing determined by HBG.**

Shipments that do not meet the minimum will be held and combined with other orders until minimum is met.

Customer may choose to set a timeframe in which HBG will either cancel the order or ship the order with a freight charge.

One day laydown titles must be ordered in carton quantities.

#### **Payment Terms**

Net 30 days based on invoice date.

#### **Calendars**

55% on all orders

Calendars do not combine with books to make minimums

#### **Free Freight**

**Markdown credits: For product sold after 12/26/19 through 2/15/20, credit equal to 50% from cost will be given. For all product sold from 2/16/20 through 3/31/20, HBG will credit 75% from cost.**

**Proof of sales must be received by 4/30/20.**

#### **Policies**

- All orders are subject to HBG approval.
- All prices are subject to change without notice.
- Promotional material cannot contain an implied endorsement without prior written approval.
- Where necessary, sales tax will be applied unless photocopy of tax-exempt certificate is supplied.
- Customer is bound to the terms of this schedule for a minimum of 12 months.
- HBG does not pay or accept vendor non-compliance chargebacks. All purchase orders are accepted and shipped subject to the terms and conditions of HBG’s terms of sale.

#### **Claims**

- Claims for calendars which have not been received must be made by written letter to the above address within 90 days of receipt of the original invoice; claims made after 90 days will not be honored. Claims for damaged product must be filed within 60 days of receipt of shipment or they will not be honored.

#### **Selected Product**

- HBG reserves the right to sell specific products under special terms which will be announced at the appropriate time.

#### **Eligibility:**

- Available only to customers in the U.S & Canada who: (1) Purchase all HBG products directly from HBG and not from another supplier and (2) remain in good credit standing as determined by HBG Customer Financial Relations.
- These terms are not available for copies sold for resale on online consumer-facing third party marketplaces.
